Tuition Policy & FACTS Registration

It is the policy of Academy of the Holy Angels, that all student families must register for the FACTS Tuition Management Program. Registration deadline is March 31, 2026.

In order to create your AHA student billing account and complete your online registration, it is mandatory that all student families register for the FACTS Tuition Management Program. FACTS is an automatic payment plan made through your checking or savings account. The plan will authorize your financial institution to make automatic payments to FACTS on a specific day each month, per your payment schedule selection. [Follow this link for FACTS Login.](#)

For the 2026-2027 academic year, we offer different tuition payment schedules according to your choosing:

- Pay in Full (by July)
- Semi-Annually (July and January)
- Quarterly (July, October, January, April)
- Monthly (ten payments July through April)

Important Payment Dates to Remember:

- **March 31** – Laptop payment due at AHA
- **March 31** – FACTS Tuition Agreement Registration
- **May 11** – Student Billing Fees will automatically be paid through FACTS
- **June 10** – Student Billing Fees will be automatically paid through FACTS

Multi-Family Agreements: If parents are separated or divorced and each parent is financially responsible, they must each register with FACTS. Both parents must provide the tuition distribution in writing to the Finance Office; one parent cannot submit on behalf of the other. FACTS agreements will be revised accordingly. Payment plans will not be activated until all required agreements are completed.

Student families with an attending student and new, incoming siblings(s) do NOT have to register for a new FACTS Plan (creating separate FACTS Plans for each student). Simply contact studentbilling@holyangels.org to add your new student information to your existing AHA FACTS Plan.

-Log in to FACTS

- Create a new sign on and password, or
- If you already have an account with FACTS with your previous school please log in with your current credentials.

-Select the “Set up a Payment Plan” link and follow the prompts to create your new Tuition Agreement with Academy of the Holy Angels, until your pending agreement is visible.

-If you have a FACTS plan with another school, using the same username and password will automatically create a link so you can access your Agreement with Academy of the Holy Angels as well as any previous schools that use FACTS.

Peace of Mind Tuition Benefit

FACTS Tuition Management Program offers the Peace of Mind (POM) Benefit. The POM Benefit will pay any eligible FACTS unpaid balance for the current school year in the event of the death of the responsible party or his/her legal spouse. Coverage is only available to individuals under age 70 and for plans that are current. If you choose the Full Pay option, you are not eligible for POM.

FINANCIAL INFORMATION

Pay in Full Discount

If you opt to pay your tuition in full in July, you will be eligible for the \$500 Pay in Full Discount (per student). Please note that any student receiving financial aid grants or scholarship and awards from AHA are not entitled to receive the Pay in Full Discount.

Sibling Discount

Holy Angels offers Sibling Discounts. A discount of \$2,000 is offered to the younger sibling (i.e. 2nd student) attending AHA at the same time. If siblings are attending both Upper School and Middle School, the Middle School rate is applied.

Please Note: The following information reflects the 2025-2026 school year. Tuition rates and policies for 2026-2027 will be updated once they are finalized and available.

Registration: \$2,000 – February 9-28 (\$1,000 tuition credit after full matriculation in October 2025*)

Tuition: \$23,950 – (July – April)

Technology Fee: \$850 - May 12

Parents' Guild Dues: \$50 – May 12

Capital Maintenance Fee: \$500 – June 10

Fundraising Fee: \$500 (per family) – June 10

E-Textbook Fee: \$275 – June 10

Athletics Busing Fee: \$350 Fee (annual per athlete)

SEVP International Student Processing Fee: \$2,000 – February 9-28

International Student Families

International student families must register for FACTS to create a Student Billing account. Tuition payment in full is due by July 20, 2026. For international payment options, please contact studentbilling@holyangels.org.

Scholarships / Angel Achievement Awards

Notifications of Scholarship and Achievement Awards are included in the student's acceptance package, and a formal letter will follow from the Finance Office.

Please note that the FACTS online application will be available beginning October 15, 2025. Applications must be submitted on or before December 15, 2025. Your 2024 Federal Tax Return, W-2 forms, and all required supporting documents will be required.
